Gene additionally asked for Board input on 'naming opportunities" for large contributor to gain "name" recognition for sponsorship of specific areas within the buildings / moving forward. He shared that we may have an opportunity to do so within the Library -Gallery Project. The general comments were positive with the stipulation that the whole building's name would not be available.

Claudia Alligood discussed the upcoming Fall Raffle Event to be held on Sept. 15<sup>th</sup> at the Bayview Golf Club. Claudia also provided an update on the Engraved Brick, Memorial Garden Project.

Sandra Harrison advised on the issues with insurance on the building. The building coverage is \$300,000 with a \$2500 deductible; for now the building is covered with liability insurance. Without objection, at Sandra's request, the balance of \$145.79 for Portico will be transferred to Exterior Improvements
