Building Committee: Sandra Harrison, Chairman, announced that the roofing contract for the school had been awarded to Stocks & Taylor and briefly reported on their progress to date. They have been working on repairs to the ceiling in the auditorium and awaiting the arrival of the shingles. They are also working on second story ceilings. There are ongoing inspections and assessments with regard to the working being done.

Membership: In the absence of Chairman Nelda Ormond, Star Credle reported that 730 membership applications had been mailed. One hundred seventy-three memberships had been received prior to the annual meeting, and sixteen additional memberships had been paid before the opening of the night's meeting.

Nominating Committee: Chairman June Wallace thanked Jim Cox and Marti Buchanan for serving on BHSP's Board of Directors for the previous three years and for the many ways in which they had helped the organization.

She then presented the three candidates under consideration for the vacant board seats: Betsy Boxer, Karen Waters and Barry Boyd. June Wallace moved to accept this slate; Mike Godley seconded the motion. Jim Cox then nominated Susan Modlin from the floor and Marti Buchanan seconded the nomination. Betsy Boxer, Karen Waters and Barry Boyd were elected as the new three-year directors for BHSP's Board of Directors.

Mike Godley moved that the meeting adjourn.

Mike Godley announced that he would serve until a replacement could be found. Barry Boyd was asked to consider the position and graciously agreed, prompting Betsy Boxer to nominate Barry Boyd for the treasurer's job and Sandra Harrison to second the nomination. Susan Modlin was nominated from the floor for the office of Vice-President. Sandra Harrison was elected to the Vice-President's post by a vote of 7 to 2.

It was announced that July 12 would be used as an orientation meeting for new board members.

Fundraising Committee: Chairman Claudia Alligood thanked everyone for the efforts in the recent Yard Sale, which earned a good profit for the organization. She also urged everyone to sell tickets for the Car Raffle, which will be completed on July 4.
