I look forward to working with the entire BHSP membership.

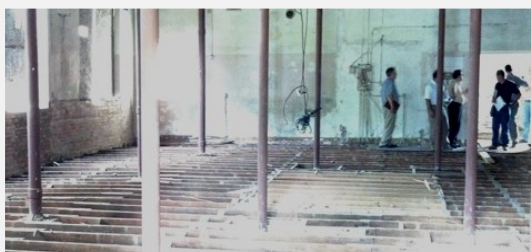
BHSP Restoration Continues...

IRA Charitable Rollover

This is something to consider as a way to contribute to BHSP. We thank you for all of your support!

A great opportunity to have an impact: The recently passed American Taxpayer Relief Act of 2012 included an extension of the IRA Charitable Rollover for 2013! As a result, individuals age 70½ and older may distribute any amount up to \$100,000 **tax-free** from an IRA to charities and not-for-profit entities such as **BATH HIGH SCHOOL PRESERVATION** through the end of 2013. This amount will count towards an individual's required minimum distribution for the year and will not be treated as taxable income.

You should consider an IRA rollover gift if:

- You are 70½ years of age or older.
- You do not itemize deductions but make charitable gifts.
- You are required to take withdrawals from your IRA but do not have an immediate or compelling need to do so.
- Your charitable gifts already equal 50% of your adjusted gross income.

Here's how it works:

- You must be 70½ years of age or older.
- You may distribute any amount up to \$100,000 to one or more charities in 2013.
- The transfer must be directly from your IRA to qualified charities; gifts to donor advised funds, private foundations, and supporting organizations are not eligible.
- The amount rolled over from your IRA will be excluded from your gross income.
- Your IRA rollover will count toward your minimum distribution requirement.
- There is no federal income tax deduction for the IRA rollover gift.
- The IRA rollover provision is effective now through December 31, 2013.
